2024 Competition Season

All Clubs, Coaches, Judges and Athletes are to be current and in good standing with USA Gymnastics in order to be eligible to enter and attend competitions. Please note all requirements to be a professional member in your respective category.

All coaches must have completed:

1. Professional Membership Payment
2. Fundamentals of Gymnastics Instruction (U100)
3. Safety Certification (U101)
4. SafeSport Certification (U110)
5. Annual Rules Update (T210)
6. Background Check through USA Gymnastics
7. Tough Coaching/Emotion Abuse (U112)
8. Concussion Education Acknowledgement

If any coach is missing any of these requirements, your status on USA Gymnastics will be marked as “Pending” and will not be permitted on the competition floor. Further, proper attire is required for professional members.

Please note that this year all athletes 18 and older must complete the Safe Sport Course. Athletes who are turning 18 before the end of the year may access the course with parent permission through the USA Gymnastics Member Services page.

Athlete Entry Fund Allocation

\$7.50 of each athlete entry at each meet is paid into the PTAU state fund in order to fund the association's operation and athlete scholarship/funding. That is rationed into sub-accounts as follows:

- a. **\$3.25** entry goes into **Travel Fund**
- b. **\$2.25** entry goes into **Judges Fund**
- c. **\$1.50** entry goes into **High School Scholarship**
- d. **\$0.50** entry goes into **Materials Fund**

Additionally, **\$1.00** from each athlete entry at each meet is paid directly to USA Gymnastics.

2023-2024 Athlete Travel Funding Plan

Assuming sufficient funds are available PTAU hopes to fund all National Team endeavors any PTAU athlete achieves. The following are the ideals assuming funds are available:

World Age Groups-Athlete	\$1500-2000*
Selected, partial funded Coach International Travel	Up to \$2000, as fund allows**
National Team Camp-Athlete	\$550 1 st camp, \$275 additional camps
EDP Camp-Athlete	\$250 per athlete
EDP Camp-Coach	Self-Funded
Jumpstart Camp-Athlete	Up to \$250
Jumpstart Camp-Coach	Self-Funded

*Funding will be distributed no less than the minimum amount, up to the top amount dependent on number of athletes attending and funds available

High School Scholarship

Four \$1500 scholarships available each year. Paid directly to the university or trade school of choice.

Eligibility:

- a. Competitive athlete from a club within PTAU
- b. Current athlete member in good standing with USAG
- c. Senior in High School or university/college/trade school student

Criteria:

- a. Application, Essay and Letter of Recommendation required
- b. State Board reviews and ranks each application package
- c. Quality of Essay, past involvement in the sport, Recommendation letter, future involvement in the sport are all taken into consideration

UTAH ELITE ATHLETE AGREEMENT

Dear Utah Elite Level Athlete;

In order to be considered for State Funding, Elite Level athletes must fulfill the following requirements:

- Compete at a minimum of two instate competitions other than my clubs competition
- Compete at the Utah State Championships.
- Volunteer my time at the Utah State Clinic at the minimum of one session other than my own.
- Participate in Utah State Championships and perform in exhibition following march-in.
- Be the best role model to all PTAU Athletes both inside and outside of the gymnastics environment.
